TERMS AND CONDITIONS

1 Issue of tender forms will be stopped at 5:00 pm on 23rd March,2020 and tender will be opened on 25th March,2020 at 1:00 P.M

2 Before tendering, the contractor shall inspect the site to fully acquaint himself about the condition in regard to accessibility site nature and extend of ground working conditions including stocking of materials, installation of tools & plants etc. Conditions affecting accomodation and movement of labour etc. required for the satisfactory execution of the work contract. No claim whatsoever on such account shall be entertained by the Department in any circumstances.

3 Tender in sealed cover shall be addressed to the Executive Engineer, Aizawl Division,Irrigation and Water Resources Department, Aizawl, Mizoram with NIT No., Name of work, No & Name of group, Sub-Head No & Name of Work clearly written on it. Unsealed Tenders shall be summarily rejected.

4 Rate must be quoted both in figure and in words.

5 Canvassing directly or indirectly in connection with the Tender is strictly prohibited and the tender submitted by the contractor, who resort to canvassing will be liable to be rejected.

6 Each page of tender book(Form-8) and SOQ should be read carefully and signed with the date on both sides after attending other needful. The Contractor should read the Specification and study the working drawing carefully before submitting tender.

7 All corrections in the Tender must be dated initialed by the Tenderer before submission of the tender, without which the tender will be rejected.

8 Canvassing directly or indirectly in connection with the Tender is strictly prohibited and the tender submitted by the contractor, who resort to canvassing will be liable to be rejected.

9 Valid Contractor Registration Certificate (*if xerox it should be attested by competent authority*) should be attached to the tender documents.

10 For Tribal tenderer, Valid House Tax Payee Certificate and Tribal Certificate (*if xerox, it should be attested by competent authority*) should also be attached to the tender documents.

11 The quoted rate must be within the workable range with reference to specific site condition of the project. Hence, rate quoted below the existing MPWD SOR(including cost index) are not adviseable and may be rejected. Therefore, contractor are advised to abide by Sl. No.2 of the Terms & Condition.

12 The tenderer or his representative may be present at the time of opening of the tender.

13 Earnest money for the work (unless exempted) in receipted Treasury Challan/Deposit Call Receipt of scheduled Bank by the Reserve Bank of India must accompany the Tender. Tenderers who do not deposit fixed earnest money in the prescribed manner will have to deposit, along with tender documents an attested copy of the letter exempting him from depositing the earnest money and shall be liable to produce original copy whenever required.


14 All tenders in which any of the prescribed conditions are not fulfilled or are incomplete in any respect are liable to be rejected.
