1. You are invited to submit your most competitive quotation for the following goods:-

2. Government of India has received a Loan from the Bank for Reconstruction and Development (IBRD) in US\$ 350 Million towards the cost of the National Hydrology Project (NHP) and intends to apply part of the proceeds of this credit to eligible payments under the contract for which this invitation for quotations is issued.

### 3. Bid Price

- a) The contract shall be for the full quantity as described above. Corrections, if any, shall be made by crossing out, initialing, dating and re-writing.
- b) All duties, taxes and other levies payable on the raw materials and components shall be included in the total price.
- c) GST shall be shown separately.
- d) The rates quoted by the bidder shall be fixed for the duration of the contract and shall not be subject to adjustment on any account.
- e) The Prices should be quoted in Indian Rupees only

4. Each bidder shall submit only one quotation.

### 5. Validity of Quotation

Quotation shall remain valid for a period not less than **30 days** after the deadline date specified for submission.

### 6. Evaluation of Quotations

- i. The Purchaser will evaluate and compare the quotations determined to be substantially responsive i.e. which
  - (a) are properly signed ; and
  - (b) conform to the terms and conditions, and specifications.
- ii. The Quotations would be evaluated for all the items together.
- iii. Sales tax in connection with sale of goods shall not be taken into account in evaluation
- iv. Goods/items with ISI certification mark or equivalent markings will be given preference.

### 7. Award of contract

The Purchaser will award the contract to the bidder whose quotation has been determined to be substantially responsive and who has offered the lowest evaluated quotation price.

7.1 Notwithstanding the above, the Purchaser reserves the right to accept or reject any quotations and to cancel the bidding process and reject all quotations at any time prior to the award of contract.

7.2 The bidder whose bid is accepted will be notified of the award of contract by the Purchaser prior to expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the purchase order.

8. **Payment shall be made immediately after delivery, commissioning/installation, and acceptance of the goods.**
9. Comprehensive warranty (Parts/Labor/Onsite)/ guarantee for all three shall be applicable to the supplied goods.
10. The bidder should be authorized dealer/ supplier for the brand he bids and certificate in support of the same should be attached.
11. The bidder should be a registered GST dealer.
12. You are requested to provide your offer latest by **12:00 noon on 2<sup>nd</sup> February, 2018.**
